### Accessibility

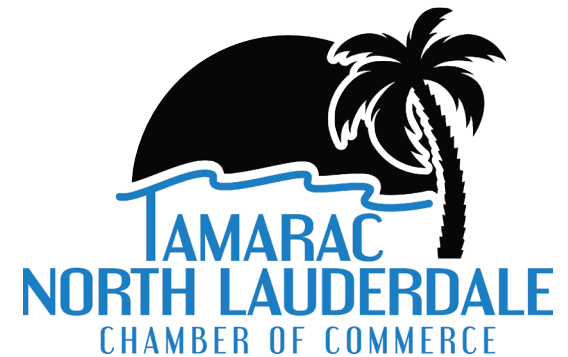
